## CANDIDATE QUALIFICATIONS

- Must be employed full time by a dues paying member in good-standing for at least one year prior to nominee consideration.
- Must be an owner of, or engaged in the senior management of a foodservice or hospitality industry company.
- Must be able to sign the Board Commitment Statement at the end of the nomination form.
- Diversity, Equity, and Inclusion: Candidates who contribute diverse perspectives, particularly those from traditionally underrepresented communities are highly encouraged to apply. Diversity can encompass attributes that are experiential, demographic, and personal.

## DIRECTOR RESPONSIBILITIES/EXPECTATIONS

- Attend and actively participate in two regularly scheduled and any additional specially-called board meeting per year (January and July).
- Set direction for, support, and defend the policies, positions, and programs of the Association.
- Attend and support DRA/DRF events and programs - both financially and direct participation.
- Contribute to the association's Political Action Committee and Foundation.
- Support the DRA/DRF Mission.
